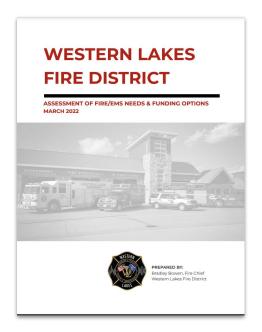

WESTERN LAKES FIRE DISTRICT ASSESSES CRITICAL NEED FOR ADDITIONAL STAFFING, NECESSARY FUNDING

Options assessment explores challenges, potential solutions to bring WLFD services in line with community needs, national standards

OCONOMOWOC, WiS. — Today, the Western Lakes Fire District (WLFD) released an options assessment detailing the staffing challenges faced by the District, the identified solutions and potential options for municipatities served by the District to provide necessary funding.

The options assessment cites increased calls for services, a growing population and decreased availability of local paid-on-call firefighters as putiling a significant strain on WLFD, resulting in increased response times that put residents at risk and increase losses due to fire.

"In just four years, we have seen a 74 percent increase in calls for service," said Bradley Bowen, Mt-FD Fire Chief. "In 2021, due to a lack of in-station staffing, our fire response times grew and does not meet national standards. We have to increase our staffing to ensure we are serving and protecting local residents to the best of our abilities."

Key to WLFD's challenge is insufficient in-station staffing to respond to calls. Currently, in-station staff must wait for paid-on-call staff to arrive before responding to the vast majority of fire calls that come in, at a time when the number of available paid-on-call staff confinues to decline.

'Historically, paid-on-call staff were from the community," said Chief Bowen. "However, since 2001, WLFD has seen a 69 percent decline in paid-on-call-staff who live within five miles of a station, dramatically increasing the time it takes for a paid-on-call staff member to report to the fire station when a call comes in - resultine in increased resconse times."

WLFD's decreased resident paid-on-call staffing is in line with the experiences of fire departments across the region, state and nation as a downward trend in available paid-on-call staff has reached an all-lime low.

Additionally, challenges tied to staff recruitment and retention have impacted WLFD. Every year, WLFD loses an average of 40 part-time staff members, larged you to higher-paying job opportunities, including with other fire departments, or other hourly job opportunities in the community. WLFD's part-time firefighter and EMS staff are currently paid \$14 an hour. For comparison, a part-time hourly salary at local convenience stores range from \$15.520 an hour.

The Western Lakes Fire District (WLFD) provides fire, rescue, and/or paramedic services in the Cty of Coonomoco, Uillage of Summit, Village of Dussman, Village of Los unann, Village of Los under the Town of Merton. The District also provides Emergency Medical Service.

In recent years, we have seen the number of residents and businesses in our service area grow. Last year, we responded to more than \$5,000 calls, an increase of more than 70% in just from years. This trend is expected to continue as the region and its population continues to develop and grow. We expect to see nearly 1,0,000 calls jee year by 2029. During this time, our faunding sources have not allowed us to increase staff nor provide competitive wages. As a result, WLFD response times, which currently do not meet national standards, will only get worse.

Declining Staffing Levels

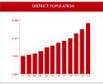
In 2001, the agencies that now make up the Western Lakes Fire District had a total of 226 staff (full-time, paid-on-call, and interns), in 2011, these communities had a total staff of 188. Ten years later, in 2012, IMED had a total staff of 188. In 10202, staffing was further reduced to 174, due in large part to WIFD's inability to offer competitive wages to recruit and retain both part-time and paid-on-call staff.

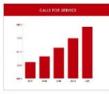
Increasing Population

During the past decade, the resident population within WLFD increased by more than 3,600 residents. In addition, there are also more commercial corridors, recreational facilities, and specialty care facilities that require services.



Increasing Calls for Service

As population and commercial growth continue, the number of calls for fire and emergency medical services grows as well. In 2017, WLFD medical services grows as well. In 2017, WLFD responded to just over 3,775 First/PMS calls for service. In 2021, WLFD responded to more than 6,500 total calls for service, an increase of more than 70% in just four years. WHAT ARE THE FUNDING OPTIONS?

To pay for the additional staffing and wage increases, we developed two options for community feedback:

OPTION 1: Collect a wheel tax

Wisconsin law allows municipalities to collect an annual municipal vehicle registration fee ("wheel tax"). - "I have been having phone conversations, and for the most part everyone is supportive once you explain the current staffing issues right now," said Dousman Village President Jack Nissen."
- "That is the case in other municipalities, according to officials, but some say the real test of support will arrive in the coming weeks as a survey is sent out to residents to gauge the level of interest in potentially raising enough money to fund the WLFD's requested budget increase."
- "These preliminary results demonstrate the value Western Lakes residents place on high-quality fire and EMS services," said WLFD Chief Brad Bowen in a news release. "This data will be incredibly useful as we determine how hest to move forward as a District."

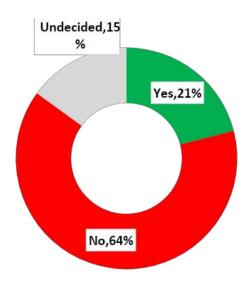

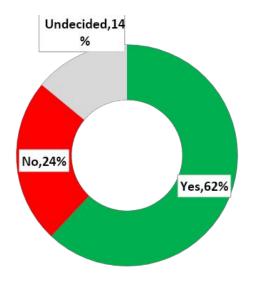
Which option(s) would you support to fund additional WLFD staff?

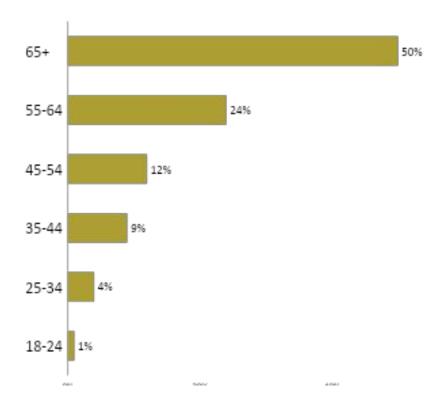

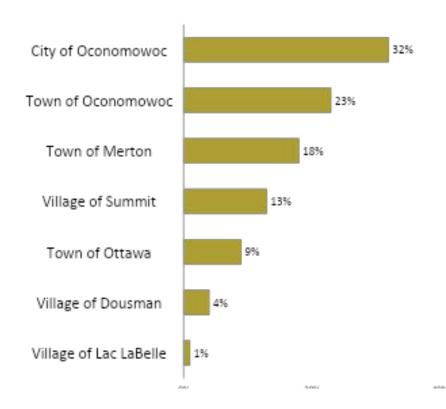

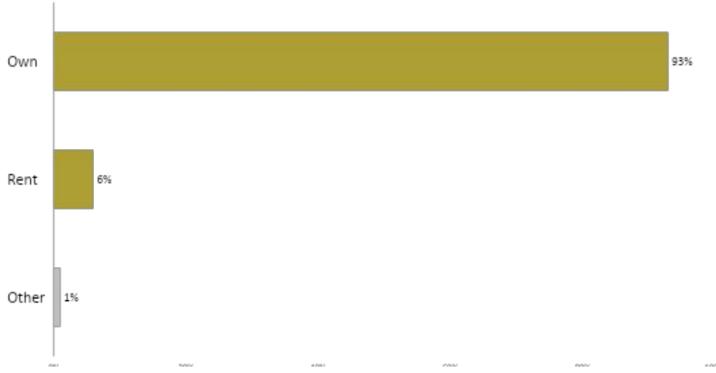
How long have you lived in the area?

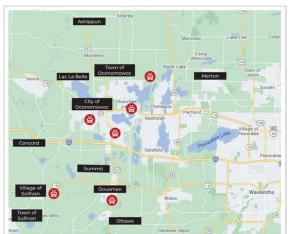
Western Lakes Fire District History

The Western Lakes Fire District (WLFD) provides:

- Basic and advanced life support (CPR, first aid, paramedic services, and invasive life-saving procedures).
- **Fire services** (fire emergencies, motor vehicle accidents, fire inspections, and public education).
- **Specialized response** (water and dive rescue, as well as large-scale incident response).
- WLFD staffs and operates five fire stations and one EMS-focused station to serve more than 54,500 residents in a 215 square mile area.



Fire Stations and Service Area



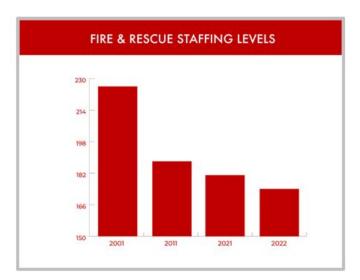

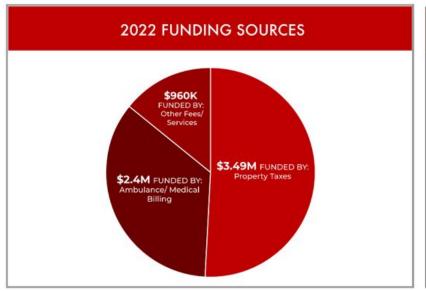
Increasing Response Times

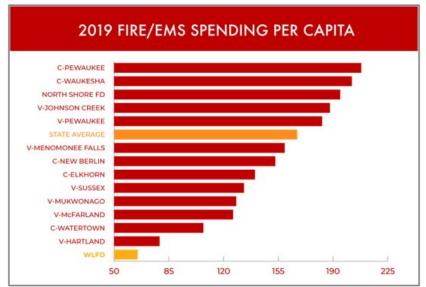
Over the past five years, fire response times have increased, challenging our ability to provide lifesaving care to residents. Currently, WLFD fire response times do not meet national standards. In the future, property owners will likely see more loss because of fires than comparable communities.

Funding Background

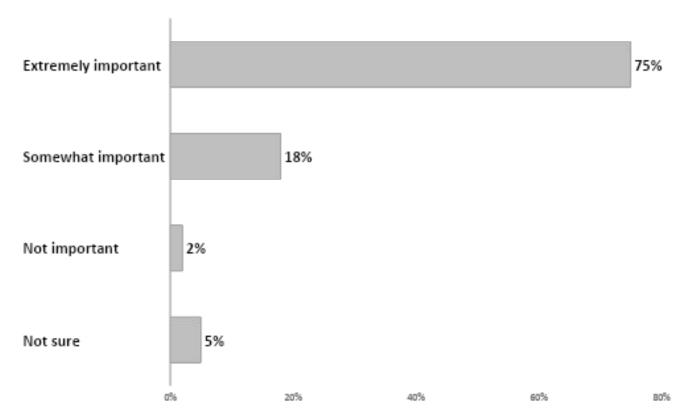
- WLFD is funded through a mix of revenue sources, including municipalities' property tax levy, state and federal payments, and fees for services (such as ambulance services, hazard mitigation, fire inspections, etc.). WLFD's 2022 operating budget is \$6.8 million, of which 80% is personnel costs related to salaries and benefits. While costs for providing fire and EMS services, as well as the demand for these services, have increased in recent years, funding for these services has remained stagnant.
- Based on the most recent data, WLFD has the lowest per capita costs when compared to peer communities.

What is needed?

Department leaders and municipal staff have assessed the needs across all WLFD communities that receive fire services. To bring fire and EMS capabilities up to appropriate levels, we will need:

- 33 additional firefighter/paramedics (11 per shift spread across our five fire stations)
- 3 battalion chiefs (one per shift) ? 12-15 paid interns (positions are not new, but the Department of Labor now requires intern positions to be paid positions)
- 1 full-time administrative assistant
- 1 fire inspector
- In addition, we need to increase staff wages to be competitive and avoid staff departures, as well as enhance staff recruitment and retention.

Increasing staffing levels would require an additional \$6.3 million each year. This investment would be shared across WLFD communities that receive fire services, based on a funding formula that accounts for a community's calls for service, population, the value of their facilities, and land value.

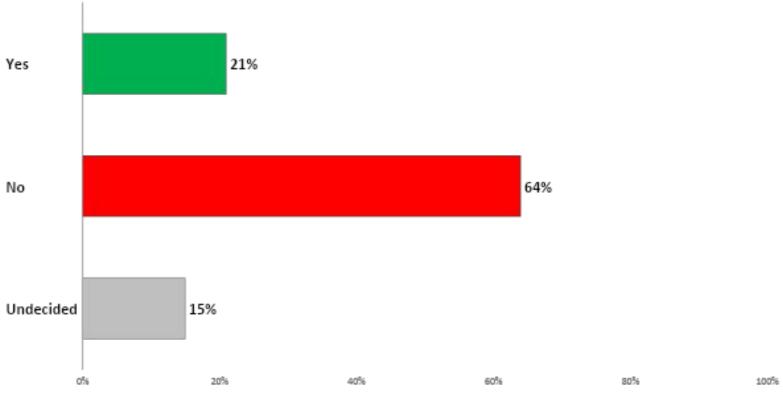

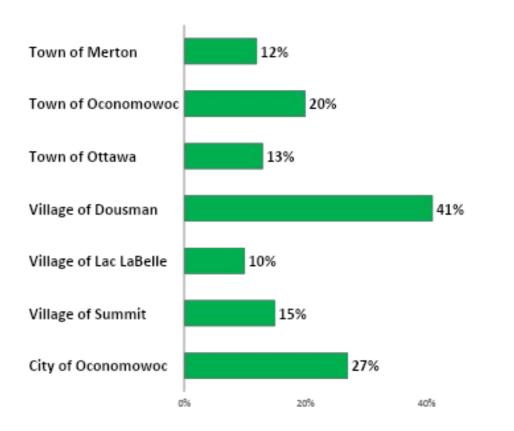
Would you support implementing a wheel tax to pay for additional WLFD staff? (Option 1)

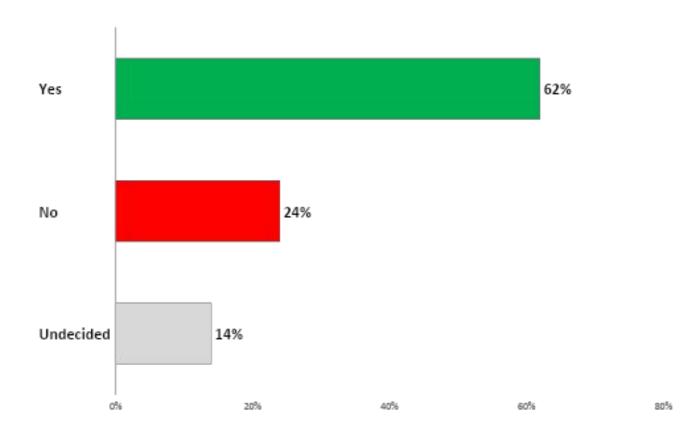

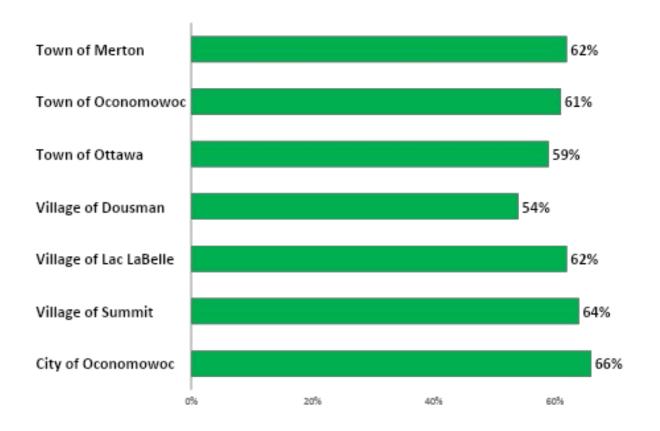

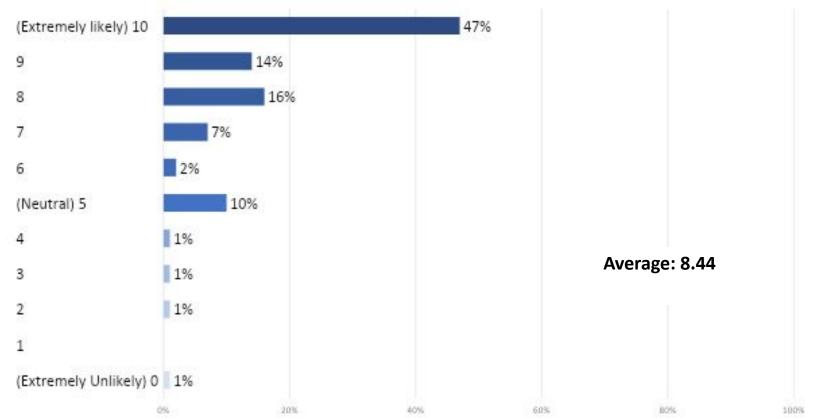

What did we learn?



- ✓ The vast majority of respondents would recommend living in the area to a friend of family member.
- ✓ 93% of respondents felt it is was either extremely important or somewhat important to have high-quality emergency services.
- ✓ A majority (62%) of respondents favored a referendum over a wheel tax (21%) to pay for additional WLFD staff.
